**Grant Application Information for the 2026-2027 Academic Year**

**Summary**

The St. Vincent de Paul Martin & Agnes Feeney Memorial Catholic Education Charitable Trust (“Feeney Charitable Trust”) was established by James and Lynda Feeney in 2006 to support those parishioners who wish to attend Catholic school on the elementary and secondary levels. The stated purpose of the trust is “to assist needy families with the costs of catholic grade school and catholic high school education . . . .”

St. Vincent de Paul parishioners are invited annually to apply for this grant. The exact amount of the grant will be established each year by the Trust Team (operating at the direction and upon the approval of the Trustee, Father Paolino) and may vary depending on availability of funds and/or the level of schooling they are pursuing.

**Requirements**

Applicants must be registered members of the parish who can demonstrate sufficient financial need for catholic school tuition assistance. Applicants’ parents/guardians must be willing to disclose income and related financial information for eligibility consideration.

**Fund Payments**

Checks will be payable directly to the catholic school as identified on the application. No checks will be payable to an individual person. Any payment to a student’s tuition account which is less than the amount awarded will be refunded to the Trust, and not payable to the family.

**Qualifying Schools**

This Feeney Charitable Trust is to support parishioners in attending any Catholic Elementary or Secondary School.

**How to Apply**

Individuals interested in applying for this grant on behalf of a parishioners-student(s) must submit a brief application along with a letter (2-3 paragraphs maximum) which follows the following format:

- Address the letter to: “Feeney Charitable Trust”, c/o St. Vincent de Paul Parish, 654 Hatboro Road, Richboro, PA 18954;
- Introduce yourself including names of family members/dependents, and in particular the parishioner-student(s) who would benefit from this grant;
- Identify which school(s) your parishioner-student(s) would like to attend and why;
- Write briefly about your desire to support Catholic Education, along with a statement generally outlining financial need for tuition support; and
- If preliminarily selected based on the above-listed criteria, a request will follow for confirmation of financial need. All submitted materials will be treated as confidential by the Pastor and any viewing member of the St. Vincent de Paul Parish Finance Committee and/or Trust Team.
- **Applications are due to the Parish Office by Monday, June 22, 2026**
